The 2025 Pig War Picnic was a resounding success! After relocating to the County Fairgrounds on Argyle Avenue, the event exceeded all expectations in size and attendance. To enhance the experience for 2026, we're excited to announce expanded food offerings, and additional activities for a full afternoon of family fun.

What's New for 2026:

- **Improved Layout:** Redesigned fairgrounds to reduce lines and wait times.
- **Revised Hours:** Now from 11:30 AM to 4:00 PM
- **Live Music:** Live Performance by Wheelie Fargo, a popular country and rock band
- **Family Favorites:** 3 legged races, sack races, egg toss, and a donut eating contest.
- **Expanded Food & Beer Garden:** More vendors, more variety, and increased seating.
- **Fireworks:** Stick around for the evening fireworks to end the day.

Proceeds benefit the families of Friday Harbor. In 2025, \$22,000 in scholarships was awarded to 11 graduating seniors.

Vendor Setup Schedule:

Vendors may set up between 12:00 pm to 3 pm on Thursday, July 3rd, or between 8am to 11:00 am on Friday, July 4th. The fairgrounds will be open to the public on Friday, July 4th from 11:30 – 4:00 pm. Vendors may take down booths beginning July 4th after 3:00 pm, or on Saturday, July 5th at 8:00 am till 12:00 pm.

Insurance Required: Vendors must provide proof of liability event insurance (minimum of \$1 million coverage) for this event, naming Friday Harbor Kiwanis Club as an additional insured under the policy. Vendor agrees to hold the club harmless from loss, damage or injury to persons or property due to vendor participation in the picnic.

Temporary Food Permit is Required by all Food Vendors:

A temporary food permit must be obtained through the San Juan County Health Community Services located at 145 Rhone Street, Friday Harbor, WA 98250(360)378-4474 or visit their website @ www.sanjuancounty.gov.

Operation: Exhibitors must confine all transactions to the space leased and shall not display signs, brochures, or advertisements, or solicit customers in any location on the grounds except within the contracted space. Tents, tables, and chairs will not be provided. Exhibitors will need to provide their own.

Signs: All signs must be neat in appearance and securely attached within their booth space. Food menu and prices must be on display for the PWP attendees.

Clean-Up/Breakdown: Please be committed to staying open until at least 3pm. If you wish you can stay open until 4pm when the band and beer garden close. Each vendor is responsible for cleaning their own booth space and should be done at the end of the event. Breakdown may not occur until 3pm. Vehicles may not enter the food court area until after the event. Vendors are required to break down and remove all trash and belongings in your booth area.

Electrical: Most booths are close to shared electric 110 volts 20-amp outlets. Vendors must furnish their own electric cords.

Water: Some of the booth areas do not have ready access to water. Vendors requiring occasional use of water for cooking and cleaning purposes must provide their own hoses, buckets, etc., and shall not allow water to overflow, leak or drain onto the ground and/or close by vendor booths.

Security: Friday Harbor Kiwanis Club will make every effort to provide adequate grounds security during the Pig War Picnic at the SJCF. The San Juan County Fairgrounds, San Juan County, and Friday Harbor Kiwanis club cannot be held responsible for any loss or damage or for any injury by or for any cause. Vendors must make provisions for the safeguarding of their displays and are urged to insure themselves against property loss or damage and against liability for personal injury.

Sound Devices: All sound devices such as radios, stereos, speakers, and any other attention-getting devices are subject to the approval of the management and must be controlled so as not to interfere with other vendors. Flashing red lights and sirens are prohibited in all areas.

Advertising Novelties & Giveaways: Advertising by means of posters on trees, buildings, or other places outside your booth area is not allowed.

Sales Tax: All product sales during the Pig War Picnic at the San Juan County Fairgrounds are subject to Washington sales tax. Tax permits are issued by the Washington Taxation and Revenue Department

State Compliance: Vendors must comply with all state and local laws and regulations, including but not limited to laws and regulations concerning taxation, health, safety, labor, employment, and licensing.

Fire Safety: Each concessionaire must maintain one workable five-pound 40 BC approved fire extinguisher in the booth area at all times.

Food Service: Vendors must sell or dispense all food and drinks in disposable paper, foam or plastic cups/plates/bowls, or aluminum cans. Drinks in glass containers are not permitted. A confirmation letter will be mailed along with any other pertinent information within ten days of receiving your application.

Please Note:

By submitting this Pig War Picnic vendor application, you acknowledge that you as the applicant have read and understand the guidelines and procedures as indicated in this PWP vendor packet. You agree to sell only those food/drink items listed on your application. If you need to change/add a new food/drink item, you must submit a request to the Kiwanis Club of Friday Harbor within two weeks of the event.

Our annual 4th of July Picnic is a fundraising event with proceeds benefiting academic scholarships for graduating high school students and other youth programs in Friday Harbor. Thank you for your participation and support.

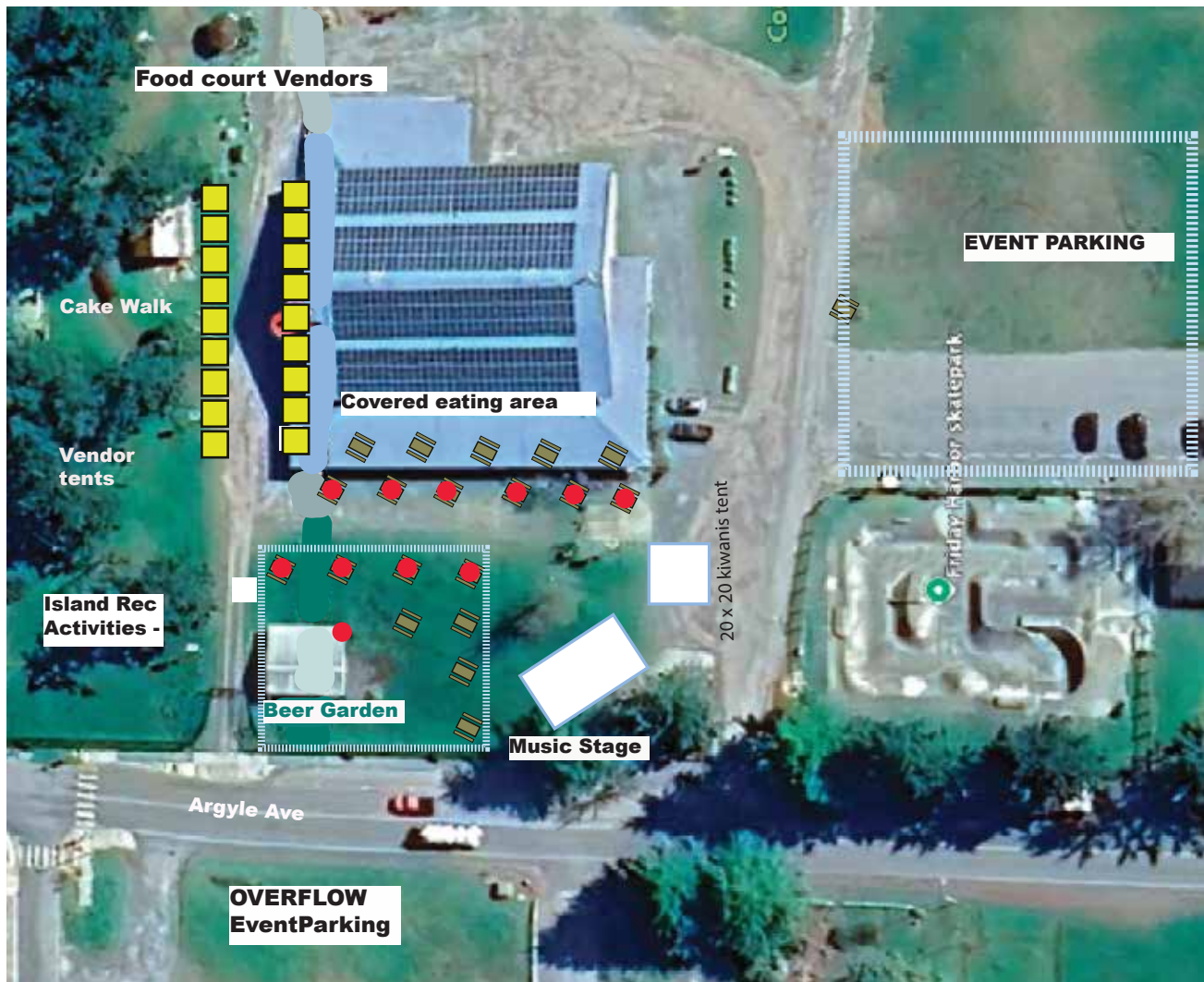

All space locations and assignments are assigned at the sole discretion of Friday Harbor Kiwanis Club on a first come basis. The Friday Harbor Kiwanis Club and San Juan County Fairgrounds assumes no responsibility for errors or omissions. The vendor agrees to hold harmless Friday Harbor Kiwanis Club and San Juan County Fairgrounds from loss or damage caused to persons or property for any cause whatsoever.

Arrival: Upon arrival, please check in with event staff at the San Juan County Fairgrounds entrance gate located at 849 Argyle Avenue, Friday Harbor WA.
